MEETING MINUTES

January 28, 2014

Meeting was called to order by Jim Barta, President at 1:07 pm. Twenty two members were present. Individual introductions were made to the group.

The Secretary's report was reviewed, accepted and seconded.

Treasurer's report was given. \$30.28 was spent on frames, leaving a balance of \$1,295.24. It was accepted and seconded.

TODAY'S SAFETY TOPIC:

Jim Barta spoke about equipment inspections (pre-shifts), task training and workplace exams. He handed out examples of their inspection sheets. The MSHA records for 2013 shows most accidents are due to lack of task training.

Sid Garay spoke of MSHA based items. He said his inspectors will be professional, thorough, get to the root cause of citation. The operator should offer mitigating circumstances. They should do this at the time the violation is found, citation is issued and at close-out. If visiting inspectors do not act professionally, Sid wants to know.

He encourages mine operators to attend the Holmes meetings.

In 2013, M/NM had 22 fatalities.

Task training, workplace exams and pre-shift exams can help to prevent injury/accidents.

The top 3 citations that the Topeka Field Office cites are, housekeeping, electrical and guarding.

There will be a tour of the Federal Building at 2:30 pm.

Arlington is starting committees to evaluate MSHA business.

Sid talked about the Small Mines Division and EFS Division.

MSHA will help you with Part 48 blue card applications.

Unofficially, MSHA may fund the State Grants programs again.
It was suggested that we meet at MSHA location every January to get the MSHA update for the past year and the upcoming events.

274 mines are inspected by the TFO each year.
