

SUNFLOWER SAFETY COUNCIL MEETING MINUTES

January 23, 2018

Meeting was called to order at 1:06 pm. Fourteen were present.

November meeting minutes were reviewed.

The treasurers report: \$600 in checking account. \$12,017.90 was deposited into the High Plains Heritage scholarship account.

We will send out the scholarship information to KAPA/KCRMA to help with distribution of information to college bound students.

The underground salt museum is using W65's from China. They are not MSHA approved.

Bob Small let us know:

- David Zatezalo is the new Assistant Secretary
- The Workplace Exam issue is still being reviewed.
- An explanation of Opening/closing forms: if doing maintenance, you are still open.
 MSHA likes to do inspections while you are in full operation. If the mine site is closed (crushing ceased), but they are still loading out, MSHA does not have jurisdiction. If the loader operator were to have an accident, MSHA may show up.
- Be sure to hit the "submit" button after filling out the quarterlies. Some operators are forgetting and then they are late.
- When testing part brakes, do not try to drive through them.

Leon Mueller informed us:

- Martin Marietta Ft. Calhoun is going underground.
- They are using a GPS system that attaches to their hard hats. It is a proximity detector that will stop the machine if to close.
- 6 power haulage fatalities for 2017 and 13 total fatalities for 2017

Old Castle is testing a similar detection device. Their device monitors 60 vehicles/second. This helps keep their construction workers from being run into. It is available to anyone who inquires about it.

Jim Barta let us know about a blasters course on February 19-21, 2018.
